NAREDCO EVENTS & ACTIVITIES

NAREDCO Participated in MoSPI Consultation on Index of Service Production (ISP)

On 11th December 2025, The Ministry of Statistics & Programme Implementation (MoSPI) convened a consultative meeting with Industry Associations to deliberate on the availability, quality, and suitability of datasets required for the compilation of the proposed Index of Service Production (ISP). Ms. Preeti Singh, Additional Director General, NAREDCO, attended the meeting, representing the real estate and allied services sector.

The consultation formed part of MoSPI's broader initiative to strengthen high-frequency indicators for the services sector, which plays a pivotal role in India's economic growth. Officials from MoSPI outlined the objectives, scope, and methodological considerations of the ISP, emphasizing the need for consistent, timely, and granular data to accurately capture sectoral performance. Industry Associations, including NAREDCO, shared sector-specific perspectives on data availability, reporting mechanisms, and practical challenges in data collection. Discussions highlighted key concerns such as heterogeneity within service sub-sectors, variations in data reporting frequency, confidentiality issues, and the need to account for evolving business models and digital service delivery platforms.

Participants collectively stressed the importance of sustained collaboration between government and industry to bridge data gaps and enhance coverage of emerging service segments. The deliberations reflected a shared commitment towards strengthening India's data ecosystem and developing a robust statistical framework that supports evidence-based policymaking. The meeting concluded with an understanding that continued stakeholder engagement and technical evaluation would be essential for refining datasets and methodologies. MoSPI reaffirmed its intent to work closely with Industry Associations to ensure that the Index of Service Production evolves as a credible, responsive, and future-ready indicator of services sector activity.



NAREDCO Organised 4th Online Management Development Program

NAREDCO successfully organised the 04th Online Management Development Program (MDP) on **“RERA & Real Estate Leadership Essentials”** from **14th to 23rd December 2025**, scheduled daily between 6:00 PM and 7:30 PM. The program focused on building regulatory understanding, leadership capability and professional excellence among real estate stakeholders, enabling participants to strengthen their knowledge and confidence under the RERA framework.

The program commenced on 14th December 2025 with a welcome note and opening remarks delivered by CA Vinay Thyagaraj, Program Director and Treasurer, NAREDCO Karnataka. The first session, led by CA Subhash R. Pangaonkar, Chairman, RERA Subcommittee, NAR India, covered the registration process of agents and channel partners under RERA, outlining their roles, responsibilities, and the significance of PMLA provisions. The session highlighted how RERA enhances transparency and protects the interests of both developers and homebuyers.

On second day, Mr. Anand Kumar, IAS (Retd.), Chairman, Delhi RERA, delivered an insightful talk on the evolution and overview of the RERA Act. He shared his perspective on regulatory transformation within the sector. The session emphasized how RERA has paved the way for structured development practices in Indian real estate.

On third day, the program moved to the technical aspects of Real Estate Project Registration under RERA, conducted by CA Gopal Lodha. The session elaborated on eligibility criteria, documentation, registration processes and extension norms associated with project approvals, enabling participants to understand procedural compliance in depth.

In fourth session, CA Bhavesh Nagda from Mumbai explained the duties and responsibilities of promoters under RERA. The session focused on periodic compliances, transparency in operations, financial discipline, and defect liability norms-elements crucial for customer trust and regulatory adherence.

The fifth session held on 18th December 2025, led by Mr. Venket Rao, Founder, Intygrat Law Offices, New Delhi, addressed standard and mandatory practices such as booking forms, allotment letters, agreement for sale and sale deeds. The discussions highlighted the recurring grievances of allottees and the importance of adopting uniform documentation practices for smoother transactions.

In sixth session, Mr. Kunal Behrani, COO, Unity Group, delivered an impactful session dedicated to Customer Relationship and Post-Sales Support. He elaborated on pre and post-sales service strategies, communication flow, defect liability periods, handover processes and building long-term customer trust. The session also highlighted service excellence benchmarks within the real estate industry.

The seventh session on GIFT City-India's International Financial Gateway was conducted by Mr. Sarang S. Jain, Managing Director, SJ Sangath Group & President, NAREDCO NextGen Gujarat, who joined as the Guest Speaker along with Mr. Piyush Gandhi, CFO, SJ Sangath Group. The discussion offered an overview of India's growing global finance infrastructure and emerging investment potential in GIFT City. The program continued with discussions on the Sales, CRM and Marketing Provisions under RERA in eighth session, conducted by CA Vinay Thyagaraj, with Shri Tarun Bhatia, Vice Chairman, NAR India, as special invitee. The discussion covered advertisement guidelines, digital marketing ethics, essential brochure elements and guidelines for responsible communication, along with practical insights on lead conversion and customer expectation management.

The ninth session was taken by Dr. Adv. Harshul Savla, D.Litt., Managing Partner, M Realty (Suvidha Lifespaces) and Author, TEDx Speaker presenting an engaging session on Branded Residences, covering India's evolving luxury housing landscape, global comparisons, future possibilities and challenges associated with the segment. It provided a forward-looking narrative on premium real estate expansion and brand-led housing model.

The tenth session featured a dynamic discussion on Negotiation Mastery, Leadership & Channel Management, led by Mr. Sahil Kapoor, NAR India, who guided participants on Brand reputation, managing channel networks, professional conduct, personal branding, and presentation skills essential for modern real estate leadership. Mr. Parneet S. Sachdev, Chairman, RERA Haryana (Panchkula), also joined the session as a Guest Speaker and shared a special address with the participants.

The 4th MDP proved to be highly enriching, covering every aspect of RERA compliance, customer engagement, ethical sales practices and leadership skills. The sessions collectively strengthened the professional capacity of participants and contributed to a more transparent, customer-centric and future-ready real estate ecosystem. The initiative reflects NAREDCO's commitment to industry education, capacity building, and empowering stakeholders with knowledge essential for sustainable sectoral growth.

Additional Director General, NAREDCO attended National Committee Meeting on “Energy Conservation in Buildings”

On 18th December 2025, A meeting of the National Committee on Energy Conservation in Buildings (NCECB) was convened, with the objective of strengthening policy coordination and accelerating the implementation of energy efficiency measures in the building sector.

The meeting focused on reviewing the Energy Conservation Building Code (ECBC) framework, progress made by States and Union Territories in its adoption and implementation, and the role of various stakeholders in promoting energy-efficient building practices. Deliberations highlighted the need for enhanced inter-ministerial coordination, capacity building at the State and Urban Local Body levels, and greater awareness among developers, architects, and engineers regarding compliance with ECBC norms.

Key agenda items included discussion on institutional mechanisms for monitoring ECBC implementation, strategies for mainstreaming energy efficiency in public and private buildings, and the integration of energy conservation measures with ongoing urban development and housing programmes. The Committee also deliberated on the importance of data availability, reporting frameworks, and periodic review to track outcomes and impact.

Ms. Preeti Singh, Additional Director General, NAREDCO, attended the meeting, representing the perspective of the real estate and housing sector. Her participation underscored NAREDCO's commitment to supporting national objectives on energy conservation and sustainable development in buildings. The role of industry bodies in facilitating stakeholder engagement, disseminating best practices, and encouraging voluntary adoption of energy-efficient technologies was emphasised during the discussions.



The meeting concluded with a consensus on the need for collaborative action between government agencies, industry associations, and technical institutions to ensure effective implementation of energy conservation policies in the building sector. The outcomes of the meeting are expected to contribute to reduced energy consumption, lower carbon emissions, and the promotion of sustainable and climate-resilient built environments across the country.



Additional Director General, NAREDCO attended Bharat Buildcon Stakeholders' Meeting

On 19th December 2025, Ms. Preeti Singh, Additional Director General, NAREDCO attended in Stakeholders' Meeting at Vanijya Bhawan, New Delhi, organised by Bharat Buildcon, aimed at strengthening policy–industry collaboration for the construction and real estate sectors.

The meeting was Chaired by Dr. Brij Mohan Mishra, IAS, Joint Secretary and Smt. Urmila IES, Economic Adviser (DPIIT), Ministry of Commerce & Industry, Govt of India. Deliberations aligned with the Hon'ble Minister Shri Piyush Goyal ji's vision of enhancing the capability, competitiveness, and long-term growth of India's infrastructure industry through collective action.

The session provided valuable perspectives on policy support, growth opportunities, and the future roadmap of the sector.



Land in the Sky: How Vertical Property Cards Could Reshape Urban India

Vertical property cards sound like a small tweak in paperwork. In reality, if Maharashtra executes the idea well, they could redraw the legal map of urban home ownership in India. For decades, the legal architecture of apartments has been out of sync with how people actually live. Nearly half of Maharashtra's population now lives in urban areas, with vertical housing in Mumbai–Pune–Thane becoming the dominant form of shelter and investment (Census 2011).

The global real estate market is projected to reach a value of US\$654.39 trillion by the end of 2025. For India to partake a significant share of this enormous pie, ease of doing business in real estate must climb from a measly 154 into the top 10.



Keynote Speaker- Shri Gaurav Jain, President Elect, NAREDCO Delhi

He emphasized the need for transformative reforms through strong state chapters, active government engagement, and inclusive platforms such as NAREDCO NextGen and NAREDCO Mahi to achieve India's 2030–2035 goals. He also touched upon Delhi's urban challenges, including slum redevelopment, outlined plans to launch six new state chapters, and informed participants about the upcoming national RERA summit scheduled for February.

Address by Shri Tokhan Sahu, Hon'ble Minister of State, Ministry of Housing & Urban Affairs, Govt. of India

Shri Tokhan Sahu expressed his appreciation to NAREDCO for providing a constructive platform to deliberate on Delhi's critical urban challenges. Highlighting Delhi's rich civilisational legacy and future potential, he stated that under the leadership of Hon'ble Prime Minister Shri Narendra Modi, the city is poised for transformative development aligned with the vision of Viksit Bharat 2047. He emphasized that urban redevelopment has become a necessity, given challenges such as population growth, limited land availability, traffic congestion, and environmental concerns.

He underscored the importance of Transit-Oriented Development (TOD) and public transport-led planning to reduce congestion, improve air quality, and enhance urban efficiency, while balancing economic growth with sustainability. Reaffirming the Government of India's support through progressive policies and simplified regulations, he emphasized the need for active industry participation and lauded NAREDCO Delhi for fostering meaningful dialogue, expressing confidence that the seminar's outcomes would contribute to a more sustainable and future-ready Delhi.



Presentation by Dr. Debolina Kundu, Director, National Institute of Urban Affairs (NIUA)



Dr. Debolina Kundu, Director, NIUA, highlighted integrated community planning, walkable high-density development, and strong stakeholder participation as essential for sustainable urban growth. Emphasizing Delhi's employment patterns, she underscored the role of Transit-Oriented Development (TOD) in bringing people closer to transit hubs and reducing car dependency. She acknowledged governance and infrastructure challenges but cited successful national TOD initiatives, including the Karkardooma Smart TOD project, as models for mixed-use, self-sustaining urban development.

She also referred to transformative initiatives such as the RRTS, multimodal transport hubs, unified metro governance, digital mobility reforms, and demand-based parking management. Concluding, she stressed the need for integrated mobility planning, rental housing near metro stations, private sector participation, and data-driven approaches to advance India's TOD vision and promote balanced urban growth.

Keynote Speaker-Shri Naveen M. Raheja, Managing Director, Raheja Developers Ltd.

Shri Naveen Raheja highlighted the need for coordinated and practical approaches to slum redevelopment, noting that a significant share of Delhi's population lives in slums and unorganised settlements.

He advocated walk-to-work, self-sustaining urban models, integrated group housing, and zero-discharge redevelopment, and proposed a single slum redevelopment authority with simplified eligibility mechanisms, expressing confidence that integrated planning can make Delhi a model for inclusive urban development.



a. Developer self-service e portal for registrations



New Delhi: Mandatory green building certification for projects, incentives for complying with policy on green buildings and penalties for not following rules are among recommendations made by a taskforce constituted to prepare a blueprint of regulatory and policy changes needed to unlock Delhi's real estate potential.

According to the report of the joint government-industry taskforce formed by the lieutenant governor, absence of clear guidelines, regulations and frameworks hinders operationalisation of green incentives by builders and developers.

Implementation of the recommendations will drive the adoption of sustainable construction practices and promote environmental stewardship, the report said. "This policy will not only benefit the environment but also offer significant advantages to developers, investors and occupants," it said.

The taskforce recommended several incentives to developers to encourage the adoption of sustainable construction practices. These include additional floor area ratio (FAR) and ground coverage, which can significantly enhance the economic viability of green projects, as builders can construct and sell more area than other projects. For instance, developers can receive up to 5% extra FAR for certified green building projects, making it more attractive to invest in sustainable

construction.

"The potential of Delhi in terms of creating business hubs and office spaces is yet to be adequately harnessed. With multiple authorities and overlapping jurisdictions, Delhi's growth has often been constrained, and better coordination can unlock its true potential," said Harsh Vardhan Bansal, president of real estate body NAREDCO-Delhi.

Green building certification has been proposed for projects exceeding a specified built-up area.

The proposed framework will help developers avoid risks associated with non-compliance and potential regulatory penalties, and align projects with global sustainability goals.

Amid concerns over worsening air quality in the national capital, union minister of state for housing and urban affairs Tokhan Sahu, at an event organised by NAREDCO-Delhi, said public transport should

be the primary mode of mobility for people living in cities rather than private vehicles.

As part of a review of the Delhi Master Plan 2021, green building provisions were discussed extensively at various levels. The Master Plan was amended to incorporate green building concepts—promoting optimal resource utilisation such as water and energy, on-site ef-

fluent treatment plants and waste management—with an aim towards zero discharge in layout plans.

However, implementation and impact of green building incentives have been limited in Delhi so far. The Draft Master Plan for Delhi-2041, meanwhile, gives minimal focus on green building rules, leaving a critical gap in policy direction.

"One of the primary challenges is the regulatory gap. The absence of specific rules, regulations and guidelines for green buildings restricts local authorities from offering meaningful incentives to developers. Without a formal policy, there is no mechanism to make additional FAR incentives available to beneficiaries, leaving developers uncertain about potential benefits," the taskforce said.

Debolina Kundu, director at the National Institute of Urban Affairs, said enhancing first-mile and last-mile connectivity in cities would play a major role in urban redevelopment, including in the national capital, and improve ease of living for residents.
